1. Introduction and Background

This Policy uses, as its baseline, the Essex County Council template dated September 2024.

Kelvedon Hatch Community Primary School (KHCCPS) recognises that positive behaviour and good attendance are essential in order for pupils to get the most of their school experience, including their attainment, wellbeing and wider life chances.

The law entitles every child of compulsory school age to an efficient, full-time education suitable to their age, aptitude, and any special educational need (SEN) that they may have. It is the legal responsibility of every parent/carer to ensure that their child receives that education either by attendance at a school or by education otherwise than at a school.

Where parents/carers decide to have their child registered at school, they have an additional legal duty to ensure that their child attends that school regularly, and on time. This means that their child must attend every day that the school is open, except in a small number of allowable circumstances, such as being too ill to attend or being given permission for an absence in advance from the school.

The Department for Education (DfE) has produced statutory guidance for maintained schools, academies, independent schools, and local authorities. It is called "[Working together to improve school attendance](#)" and it includes a National Framework in relation to absence and the use of legal sanctions. The KHCCPS Attendance Policy reflects the requirements and principles of that guidance.

This Policy is written with the above guidance in mind and underpins the KHCCPS ethos to:

- promote children's welfare and safeguarding;
- ensure that every pupil has access to the full-time education to which they are entitled;
- ensure that pupils succeed whilst at school;
- ensure that pupils have access to the widest possible range of opportunities at school, and when they leave school.

The Policy has been developed in consultation with school governors, teachers, local Headteacher Associations, the Local Authority and parents and carers. It seeks to ensure that all parties involved in the practicalities of school attendance are aware and informed of attendance matters in school and to outline the KHCCPS commitment to attendance matters. It details the responsibilities of individuals and groups involved and the procedures in place to promote and monitor pupil attendance.

In addition, all schools follow the DfE's statutory safeguarding guidance, [Keeping Children Safe in Education](#), which emphasises the importance of understanding the potential vulnerabilities of children, who are missing or absent from education.

This KHCCPS policy aims to raise and maintain levels of attendance by:

- promoting a positive and welcoming atmosphere in which pupils feel safe, secure and valued;
- raising and maintaining a whole school awareness of the importance of good attendance and punctuality;
- ensuring that attendance is monitored effectively and that reasons for absences are recorded promptly and consistently.

For KHCPs children to gain the greatest benefit from their education, it is vital that they attend regularly and be at school, on time, every day on which the school is open unless the reason for the absence is unavoidable. **It is a rule at KHCPs that pupils must attend every day, unless there are exceptional circumstances, and it is the Headteacher (HT), not the parent/carer, who can authorise the absence.**

2. Promoting Regular Attendance

KHCPs believes in developing good patterns of attendance and sets high expectations for the attendance and punctuality of all pupils from the outset. It is a central part of the KHCPs vision, values, ethos and day-to-day life. KHCPs recognises the strong connections between attendance, attainment, safeguarding and wellbeing.

Helping to create a pattern of regular attendance is the responsibility of parents/carers, pupils and all members of KHCPs staff.

To help everyone to focus on this, KHCPs:

- Submits a daily attendance return to the DfE's, in line with the legal expectations placed on all schools;
- Builds strong relationships and works jointly with families;
- Provides parents/carers with details on attendance in its newsletters, including articles and attendance data;
- Promotes the benefits of high attendance;
- Accurately completes admission and attendance registers and has effective day-to-day processes in place to follow-up absence as required by law;
- Celebrates excellent attendance by displaying and reporting individual and class achievements;
- Rewards good or improving attendance;
- Celebrates attendance in weekly celebration assemblies;
- Awards badges, stickers and certificates to children for 100% attendance;
- Reports to parents/carers regularly on their child's attendance and the impact on their progress;
- Contacts parents/carers should their child's attendance fall below the KHCPs target for attendance.

3. Understanding Types of Absence

Any absence affects the routine of a child's schooling and regular absence seriously affects their learning journey and ability to progress. Any pupil's absence or late arrival disrupts teaching routines and so may affect the learning of others in the same class. Ensuring a child's regular attendance at

school is a parental responsibility and allowing absence from school, without a good reason, creates an offence in law and may result in prosecution.

Every half-day absence from school has to be classified by KHCPs (not by the parent/carer), as either **authorised** or **unauthorised**. This is why information about the cause of any absence is always required. Each half-day is known as a 'session'.

Authorised absences are morning or afternoon sessions away from KHCPs for a genuine reason, such as illness (although parents/carers may be asked to provide medical evidence for a child before this can be authorised), medical or dental appointments, which unavoidably fall in school time, emergencies or other unavoidable cause.

Unauthorised absences are those which KHCPs does not consider reasonable and for which no 'leave' has been granted. This type of absence can lead to KHCPs referring to the Local Authority (LA) for penalty notices and/or legal proceedings.

Unauthorised absence includes (this list is not exhaustive):

- parents/carers keeping children off school unnecessarily, e.g. because they had a late night or for non-infectious illness or injury that would not affect their ability to learn;
- absences, which have never been properly explained;
- children, who arrive at KHCPs after the close of registration, are marked using a 'U'. This indicates that they are in school for safeguarding purposes. However, this is counted as an absence for the session;
- shopping trips;
- looking after other children or children accompanying siblings or parents/carers to medical appointments;
- their own or family birthdays;
- holidays taken during term time, not deemed 'for exceptional purposes' by the HT, including any arranged by other family members or friends;
- day trips;
- other leave of absence in term time, which has not been agreed.

4. Persistent Absenteeism (PA) and Severe Absenteeism (SA)

A pupil is defined by the Government as a '**persistent absentee**' when they miss 10% or more schooling across the school year for any reason; this can be authorised or unauthorised absence. Absence at this level causes considerable damage to any pupil's education and KHCPs needs the full support and cooperation of parents/carers to resolve this. All pupils, who have attendance levels of 90% or below, are considered to be a persistent absentee.

A pupil, who has missed 50% or more schooling, is defined by the Government as '**severely absent**'. Pupils within this cohort may find it more difficult to be in school or face bigger barriers to their regular attendance and, as such, are likely to need more intensive support.

5. Absence Procedures

KHCPS thoroughly monitors and reviews all pupils' absence, and the reasons that are provided.

If a child is absent from KHCPS, the parent/carer must follow the following procedures:

- Contact KHCPS on the first day of absence before 09.10 when the register closes;
- KHCPS has an answer phone available to leave a message if nobody is available to take a parent/carer call, or parents/carers may call into KHCPS personally and speak to the School Office staff. Parents and carers should be aware that, if they leave a voicemail to report a child's absence, they may receive a call from KHCPS in order to discuss the absence before deciding as to whether the absence is to be recorded as authorised;
- Contact KHCPS on every further day of absence, before 09.10;
- Ensure that a child returns to school as soon as possible and that they provide any medical evidence, if requested, to support the absence. Medical evidence may be requested where a child is having multiple periods of absence, which are reported as being due to medical reasons. When determining whether a child is too ill to attend school, both parents/carers and KHCPS staff can consider the advice contained within the NHS and Essex County Council Guidance on School Absence and Childhood Illness (Appendix B).

If a child is absent, KHCPS:

- Telephones or texts parents/carers on the first, and every subsequent, day of absence, if it has not heard from them. However, it is the responsibility of parents/carers to contact KHCPS;
- If the School Office is unable to contact parents/carers by telephone, staff telephone emergency contact numbers, send letters home and a home visit may be made, in the interests of safeguarding;
- A referral is made to the LA if no contact has been made with parents/carers by the tenth day of absence (or sooner if deemed appropriate), at which point a child will be considered to be "missing from education."

A list of attendance for each class is recorded in the School Office with children absent marked.

Any children arriving between 08:40 and 09:10 are given a late mark. Parents/carers are asked to sign their child in electronically, and to provide a reason for the absence.

Any children arriving after 09:10 without valid reason or authorisation are given an unauthorised absence (U) code in the register.

The HT is informed of any absent children, who currently have low attendance, or are a safeguarding concern.

The same attendance register is completed at 13:00 at the start of the afternoon session.

If absence continues, KHCPs can:

- Write to parents/carers if a child's attendance is causing concern, including, but not exclusively, if attendance falls below 90%, and/or where punctuality is a concern;
- Invite parents/carers into School to discuss the situation with the HT or a member of the KHCPs Senior Leadership Team (SLT);
- Create a personalised action/support plan, such as an attendance contract, which includes the setting of attendance targets, to address any barriers to attendance and makes clear each person's role in improving the attendance patterns of the child;
- Offer signposting support to other agencies or services;
- Issue a legal warning letter;
- Refer the matter to the LA for relevant legal sanctions, if attendance deteriorates further.

6. Lateness

Poor punctuality is unacceptable and can sometimes lead to irregular school attendance patterns. Good time-keeping is a vital life skill, which will help children as they progress through their school life and out into the wider world.

Pupils, who arrive late, disrupt lessons and, if a child misses the start of the day, they can feel unsettled and embarrassed and risk missing vital work and important messages from their class teacher.

The times of the start and close of the school day for all pupils at KHCPs are:

- Gates open: 08.25;
- Doors open: 08.30;
- Registration closes: 08.40;
- End of the school day: 15.15.

How KHCPs manages lateness:

- The school day starts at 08.30 when children can begin to come into school;
- Registers are taken at 08.40;
- Children arriving after 08.40 are required to come into school via the School Office. They need to be accompanied by a parent/carer and parents/carers must sign children in using the electronic system and must provide a reason for their lateness, which is recorded.
- At 09.10, the registers are closed. In accordance with the Regulations, if a child arrives after that time, they receive a mark that shows them to be on site – 'U' (unless the lateness has been approved), but this does not count as a present mark and it means that they have an unauthorised absence;
- KHCPs may contact parents/carers regarding lateness;

Unauthorised lateness could result in KHCPs making a referral to the LA for sanctions and/or legal proceedings. If a child has a persistent lateness record, parents/carers are asked to meet with the HT, but they can approach the School at any time if they are having difficulties getting their child to school

on time. KHCPs expects parents/carers and staff to encourage good punctuality by being good role models to children and, as a school, celebrates good class and individual punctuality.

7. Understanding Barriers to Attendance

Whilst any child may occasionally have time off school because they are too unwell to attend, sometimes they can be reluctant to attend school. Any barriers preventing regular attendance are best resolved between KHCPs, the parents/carers and the child. If a parent/carer thinks that their child is reluctant to attend school, KHCPs works with that family to understand the root problem and provide any necessary support. KHCPs can use outside agencies to help with this, such as the School Nurse, Mental Health and Emotional Wellbeing support services, a Child and Family Support Worker or the relevant LA team/s. Where outside agencies are supporting the family, parents/carers may be invited to attend a Team Around the Family meeting (TAF) to consider what is working well and what needs to improve. An individual support plan will be agreed and subsequently reviewed.

Some pupils face greater barriers to attendance than their peers. These can include pupils, who suffer from long-term medical conditions, or who have special educational needs and disabilities, or other vulnerabilities. High expectations of attendance remain in place for these pupils. However, KHCPs works with families and pupils to support improved attendance whilst being mindful of the additional barriers faced. KHCPs can discuss reasonable adjustments and additional support from external partners, where appropriate.

Under the DfE's statutory guidance, schools are required to submit a sickness return to the LA for all pupils, who have missed/are likely to miss, 15 or more school days (consecutive or cumulative) due to medical reasons/illness.

Refer to Appendix C for summary tables of responsibilities for school attendance.

8. Local Authority Attendance Support Services

LA Attendance Specialists work strategically by offering support to schools, to reduce persistent absence and improve overall attendance.

Parents/carers are expected to work with KHCPs and the LA to address any attendance concerns. Parents/carers should proactively engage with the support offered, aiming to resolve any problems together. This is nearly always successful. If difficulties cannot be resolved in this way, KHCPs may consider more formal support and/or refer the child to the LA. If attendance does not improve, legal action may be taken in the form of a Penalty Notice (see Appendix D for the Essex County Council Code of Conduct) or prosecution in the Magistrates Court.

9. School Attendance and the Law

New legislation was passed, The School Attendance (Pupil Registration) (England) Regulations 2024 which introduced a National Framework in England. By law, all children of compulsory school age must receive an appropriate full-time education (Education Act 1996). Parents/carers have a legal duty to ensure that their child attends school regularly at the school at which they are registered.

Parents/carers may be recognised differently under education law, than under family law. Section 576 of the Education Act 1996 states that a 'parent', in relation to a child or young person, includes any person who is not a parent (from which can be inferred 'biological parent') but who has parental responsibility, or who has care of the child.

A person typically has care of a child or young person if they are the person with whom the child lives, either full or part time and who looks after the child, irrespective of what their biological or legal relationship is with the child.

10. National Framework for Penalty Notices

There is now a single consistent national threshold for when a penalty notice must be considered by all schools in England, of ten sessions (usually equivalent to five school days) of unauthorised absence within a rolling ten school week period. The ten sessions of absence do not have to be consecutive and can be made up of a combination of any type of unauthorised absence (G, O and/or U coded within the KHCPs registers). The ten school week period can span different terms, school years or education settings.

Sanctions may include issuing each parent/carer (for each child) with a Penalty Notice for £160, reduced to £80 if paid within 21 days (for the first offence). A second Penalty Notice issued within a three year period results in a fine of £160 per parent/carer, per child. If a third offence is committed, the matter may be referred to the LA for consideration of prosecution via the Magistrates Court. If prosecution is instigated for irregular school attendance, each parent/carer may receive a fine of up to £2,500 and/or up to three months in prison. If a parent/carer is found guilty in court, they receive a criminal conviction.

See Appendix D for the Essex County Council Code of Conduct.

There is no entitlement in law for pupils to take time off during term-time to go on holiday or be otherwise absent for the purpose of leisure or recreation, or to take part in protest activity in school hours. In addition, the Supreme Court has ruled that the definition of regular school attendance is "in accordance with the rules prescribed by the school."

The School Attendance (Pupil Registration) (England) Regulations 2024 set out the statutory requirements for schools. All references to family holidays and extended leave have been removed. The amendments specify that HTs may not grant any leave of absence during term-time unless there are "exceptional circumstances" and they do not have any discretion to authorise up to ten days of absence each academic year.

It is a KHCPs rule that a leave of absence is not granted in term-time unless there are reasons considered to be exceptional by the HT, irrespective of the child's overall attendance. Only the HT or their designate (not the LA) may authorise such a request, and all applications for a leave of absence must be made in writing, in advance, on the prescribed form provided by KHCPs. KHCPs usually considers that the parent/carer, who has made the application, is, therefore, allowing the leave of absence, and also that all parents/carers, who are on the holiday, are allowing the leave. Where a parent/carer removes a child after their application for leave has been refused, or, where no application was made to KHCPs, the absence is recorded as unauthorised. It is likely that penalty notices will be requested, in line with the National Framework and Essex County Council Code of Conduct, in respect of each parent/carer believed to have allowed the absence.

At KHCPs, 'exceptional circumstances' are interpreted as:

... being of unique and significant emotional, educational or spiritual value to the child, which outweighs the loss of teaching time (as determined by the HT). The fundamental principles for defining 'exceptional' are events that are "rare, significant, unavoidable and short". By 'unavoidable', KHCPs means an event that could not reasonably be scheduled at another time, outside of school term time, regardless of who has planned or paid for the holiday or absence (including grandparents or other family or friends).

The HT may discuss the leave of absence request with other education settings and/or the LA to determine any exceptional circumstances.

If leave of absence is authorised, KHCPs does not provide work for children to do during their absence. Parents/carers are, however, advised to read with their children and encourage them to write a diary while they are away.

11. Deletion from Roll

For any pupil leaving KHCPs, other than at the end of Year 6, parents/carers are required to complete a 'Leavers' form, which can be obtained from the School Office. This provides KHCPs with the following information: Child's name, class, current address, date of leaving, new home address, name of new school, address of new school. This information is essential to ensure that KHCPs knows the whereabouts and appropriately safeguards all of its pupils, even those who leave KHCPs.

It is crucial that parents/carers keep KHCPs updated with current addresses and contact details for the pupil and key family members, in case of emergency.

Under Pupil Regulations 2006, all schools are now **legally required** to notify their LA of **every new entry** to the admission register **within five days** of the pupil being enrolled. In addition to this, **every deletion** from the school register must also be notified to the LA, as soon as the ground for deletion has been met in relation to that pupil, and, in any event, no later than the time at which the pupil's name is deleted from the register. This duty does not apply when a pupil's name is removed from the admission register at a standard transition point – when the pupil has completed the final year of education normally provided by that school.

12. Absence Data

KHCPs uses data to monitor, identify and support individual pupils or groups of pupils when their attendance needs to improve, and schools are required to submit pupil attendance data to the DfE on a daily basis in accordance with the Education (Information about Individual Pupils) (England) (Amendment) Regulations 2024. Persistently and severely absent pupils are tracked and monitored carefully. KHCPs also combines this with academic tracking, as increased absence affects attainment.

KHCPs shares information and works collaboratively with other schools in the area, LAs, and other partners, when absence is at risk of becoming persistent or severe.

Kelvedon Hatch Community Primary School **ATTENDANCE FLOWCHART**

Daily monitoring of attendance will involve checking for regular absence patterns and sending home truancy alerts for pupils who are absent, where no reason has been provided.

We expect 100% attendance from every pupil at Kelvedon Hatch.

We celebrate good attendance through weekly assemblies, class rewards, newsletters, letters home, and termly presentations in assembly.

PUNCTUALITY: Pupils should be on site ready to come into school at 08.30. Doors close at 08.40. Pupils, who arrive after the registers have closed at 09.10, will have their absence recorded as unauthorised (code 'U') unless evidence can be provided that the absence should be considered as authorised.

The School Office staff will conduct a wellbeing call home to the parent/carer on the first day of absence and will conduct follow-up calls each day until the child returns.

HOW TO REPORT YOUR CHILD'S ABSENCE

If absence persists and falls below **98%**, a call will be made by a member of the Senior Leadership Team.
Please note absences will only be classified as authorised where medical evidence is provided if requested and this is at the school's discretion to do so.

If you need to report your child as absent, please notify the school **by phone or email before 08.30 on every day of your child's absence.**

The School Office staff will escalate a safeguarding concern if a reason for absence has not been provided by the second day of absence, and a home visit will be conducted.

If absence persists, a meeting will be scheduled with the parent/carer and pupil to discuss attendance concerns and to complete a plan to support improved attendance.

An Attendance Plan will be implemented to improve the pupil attendance. This will be reviewed every two weeks.

Any unauthorised holidays taken during term time will lead to a Fixed Penalty Notice Warning letter being issued on the first day of absence. After the second day of unauthorised holiday, Essex County Council will be contacted to request a Fixed Penalty to be issued.

If parents/carers or pupils do not engage with the strategies put in place by the school, and absences continue and drop, the Local Authority will be contacted and a Fixed Penalty Notice (FPN) application will be submitted.

When 15 sessions of unauthorised absence are reached (this can include absence from a previous term), the school will apply to the Local Authority for a FPN to be issued.

Severely absent pupils – pupils with 50% attendance or below: the Local Authority and external agencies will be notified. Support will be requested, which may include a whole family plan, consideration of an alternative form of educational provision etc. A Service Request Form will be completed by the school.

REPORTING ABSENCE AND MAKING AN ABSENCE REQUEST

For a child/young person to reach their full educational achievement, a high level of school attendance is essential.

Discovery Educational Trust (DET) and Kelvedon Hatch Community Primary School (KHCP) are committed to providing an education of the highest quality for all pupils and endeavour to provide an environment where all pupils feel valued and welcome.

Every child/young person has a right to access the education to which they are entitled. Parents/carers and teachers share the responsibility for supporting and promoting excellent school attendance and punctuality for all.

ABSENCE:

If you need to report your child absent, please notify the school by phone or email to the School Office **before 08.30** on the first day of absence **and for each subsequent day**.

When reporting your child absent, please state:

- Your name;
- Your child's name and form group;
- The reason for absence (this must be specific and not just 'illness');
- A contact number for the person leaving the message.

REQUESTING A LEAVE OF ABSENCE:

Please book any medical appointments around the school day where possible. Parents/carers must notify the school in advance of any pre-arranged absence or treatment. **This should be within 48 hours of the appointment made and a copy of the appointment record should also be shared with the school when requesting absence, so that this can be authorised. This request must be made to the Headteacher via the School Office.** We ask parents/carers to only request leave of absence for such appointments **in exceptional circumstances**. Without this evidence, the absence will be unauthorised.


Applications for 'Leave of Absence' for other circumstances, e.g. attending a family member's graduation, attending a funeral, dance and music examinations etc. must be applied for to the Headteacher (via the School Office) in writing and in advance, and before any travel arrangements are made.

Appendix E: Helping Parents to Understand the Changes to Fines for Term-Time Holidays



Helping parents to understand the changes to fines for term time holidays

With the introduction of the new National Framework for Penalty Notices, the following changes will come into force for Penalty Notice Fines issued for unauthorised holidays recorded by schools after 19th August 2024.

Who may be fined?

Penalty Notice Fines are issued to each parent who allows their child to be absent from school.

For example: 3 siblings absent for term time leave, would result in each parent who allowed the holiday receiving 3 separate fines.

First Offence

The first time a Penalty Notice is issued for an unauthorised term time holiday the fine amount will be:

£80 per parent, per child if paid within 21 days.

Increasing to £160 if paid between days 22-28.

National Threshold

There will be a single consistent national threshold for when a penalty notice must be considered by all schools in England of 10 sessions (usually equivalent to 5 school days) of unauthorised absence within a rolling 10 school week period.

These sessions do not have to be consecutive and can be made up of a combination of any type of unauthorised absence.

For example: a 5 day holiday would meet the national threshold.

The 10-school week period can span different terms or school years.

Second Offence

(within 3 years)

The Second time a Penalty Notice is issued for unauthorised absence the amount will be:

£160 per parent (who allowed the holiday), per child, payable within 28 days.

Third Offence and Any Further Offences (within 3 years)

The third time an offence is committed a Penalty Notice will not be issued and local authorities will need to consider other available measures to address the absence concerns. This may mean that cases are presented before a Magistrate's Court. Prosecution can result in criminal records and fines of up to £2,500.

Cases found guilty in the Magistrates' Court can show on the parent's future DBS certificate due to 'failure to safeguard a child's education'.
