As a result of the new equipment being in place, children have experienced positive play at lunchtimes and there have been fewer incidents of poor behaviour. Due to changes in staffing, formal positive play training for lunchtime staff has not yet taken place. However, lunchtime staff have been guided by senior leaders to support positive play at this time.
